**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article 1. Name and Address**

The name of the Corporation is: CommerceLink, Inc. The principal office, or the mailing address of the Corporation is: 13701 Whitebark Place, Tampa, Florida 33625.

**Article 2. Duration**

The duration of the Corporation is perpetual.

**Article 3. Purpose**

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

The specific purpose for which the Corporation is organized is to render the following services: provide human resource services including, but not limited to, executive search, recruiting, and placement of business professionals; and to own and operate the associated facilities, equipment and real estate to render such services.

**Article 4. Shares**

The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$0.00 per share.

**Article 5. Initial Registered Office and Agent**

The street address of the initial Registered Office of the Corporation is 13701 Whitebark Place, Tampa, Florida 33625; and the name of its initial Registered Agent at that address is Dale Gordon.

**Article 6. Initial Board of Directors**

The number of Directors constituting the initial Board of Directors is one. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. The name and address of each initial Director of the Corporation is as follows:

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

**Article 10. Indemnification**

The Corporation shall indemnify to the full extent permitted by law any person who is made, or threatened to be made, a party to any action, suit or proceeding (whether civil, criminal, administrative or investigative) by reason of the fact that he/she is or was a Director, Officer, employee or agent of the Corporation or serves or served any other enterprise at the request of the Corporation.

**Article 11. Commencement of Corporate Existence**

In accordance with Section 607.0203, Florida Statutes, the

date when corporate existence shall commence is the date of subscription and acknowledgement of these Articles of Incorporation, except that if they are not filed by the Department of State of the State of Florida within five (5) days, exclusive of legal holidays, after that date, then corporate existence shall commence upon filing by the Department of State.
