ARTICLE I - NAME

The name of the corporation is ----- PALM BUILDERS AND REMODELING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

BUILDING CONTRACTOR and shall include the

transaction of any and all lawful business for which corporations may be  
incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK



ARTICLE IX - POWERS


