**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

**ARTICLE I. NAME**

The name of the corporation shall be Realty Centre of North Florida, Inc.

**ARTICLE II. PRINCIPAL OFFICE**

The principal office of the corporation shall be in Tallahassee, Florida. The corporation may have such other offices as may be designated by the Board of Directors.

**ARTICLE III. DURATION**

The period of duration of this corporation is of perpetual existence, unless dissolved according to law. Existence of this corporation shall commence upon filing of corporate papers in accordance with Florida law.

**ARTICLE IV. PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business activities permitted under Florida Statutes.

**ARTICLE V. NUMBER OF SHARES**

The corporation shall be authorized to issue 3000 shares. Such shares are to consist of one class only, having identical voting rights of one vote per share, with a par value of \$0.01 per share.

**ARTICLE VI. OFFICE**

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

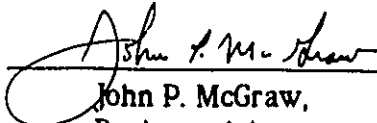
### ARTICLE VIII. AMENDMENT

### ARTICLE IX. REGISTERED AGENT

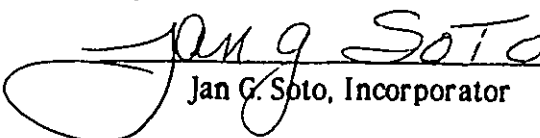
