ARTICLE I - NAME OF CORPORATION

The name of this corporation is: **Allentown Community Farm Center, Inc.**

ARTICLE II - PURPOSE

The purpose of this corporation is to operate a community farm center and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT


ARTICLE IX - BYLAWS



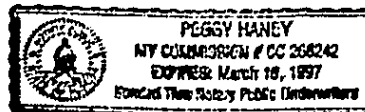
