ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation for profit under Chapter 621 of the Florida Statutes, as amended.

ARTICLE I - NAME

The name of this corporation is:

Arsenia P. Alignay, M.D., P.A.

ARTICLE II - INITIAL PRINCIPAL OFFICE

The initial principal office of the corporation is:

ARTICLE III - DURATION

The corporation is to commence its corporate existence on the date of filing by the Secretary of the State of Florida. This corporation shall exist perpetually.

ARTICLES IV.

LICENSED SHAREHOLDERS AND OFFICERS

All shareholders and officers of this corporation shall be duly licensed by the State of Florida to perform the same professional service for which the corporation is organized. No professional services shall be rendered except through duly licensed officers, employees or agents of the corporation. Any shareholder, officer, agent or employee of this corporation who becomes legally disqualified to render services for the corporation or who accepts employment that places restrictions or limitations upon his rendering of professional services for the corporation, shall sever all employment with, and financial interest in, the corporation.

ARTICLE V - PURPOSE

This corporation is organized for the following purposes:

- (a) Family medical practice

(b) The transaction of any and all other lawful business for which professional service corporations may be incorporated and the doing of all lawful things related thereto.

ARTICLE VI - CAPITAL STOCK

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One and No/100 Dollars (\$1.00) par value common stock. Each outstanding share, regardless of class, shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the shareholders, unless otherwise designated as "NONVOTING" by a resolution recorded in the corporation's minute book and a similar legend on the subject certificate(s). The shares of stock may be issued for such consideration, having a value not less than the par value of the shares issued therefor, as is determined from time to time by the board of directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation.

ARTICLE VII - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time but shall never be less than one (1). All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors. Any and all of the powers and duties conferred to or imposed upon the board of directors, by resolution of the shareholders adopted at a special meeting called for that purpose, may be exercised or performed to such extent and by such person or persons as shall be provided by the shareholders.

ARTICLE IX - RESTRAINT ON TRANSFER OF SHARES

The shareholders may, by agreement, impose any reasonable restraint on the transfer or alienation of shares.

ARTICLE X - INDEMNIFICATION

The corporation may indemnify any present or former officer, incorporator, or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.

ARTICLE XI - AMENDMENT



These Articles of Incorporation may be amended by a simple majority vote of the voting stock of the corporation that is present at any regular meeting of the shareholders or at any special meeting of the shareholders called for that purpose at which a quorum is present. These Articles of Incorporation may be amended without a meeting as provided for in the Bylaws.


