The undersigned subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be FLETCHER BUSINESS SERVICES, INC., and its initial post office address and principal office for the conduct of business is 415 Beckrich Road, Suite 400, Panama City Beach, Florida 32407. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE II

This corporation shall have perpetual existence

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business, without limit.

ARTICLE IV
