THE UNDERSIGNED, acting as sole incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation (the "Corporation") is Peggy's Cakes & Candy Supplies, Inc., whose principal office and mailing address is 6228 Parkers Hammock Road, Naples, Florida 33962.

ARTICLE II - NATURE OF BUSINESS

The purpose or purposes for which the Corporation is organized are: to engage in the business of cakes, candy supplies and products, and to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock, and the par value of each such share is One Dollar (\$1.00), amounting in the aggregate to One Thousand and No/100 Dollars (\$1,000.00).

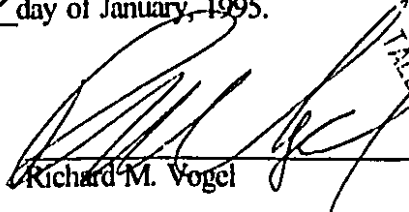

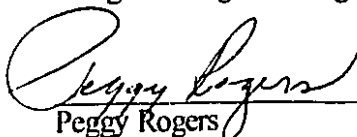
