ARTICLES OF INCORPORATION FOR Second Opinion Automotive Diagnostics, Inc.

ARTICLE I

The name of the corporation shall be Second Opinion Automotive Diagnostics, Inc. The initial address and initial place of business shall be at 2399 SunValley Circle, Winter Park, FL 32792.

ARTICLE II

The commencement of corporate existence shall be the date of filing these Articles of Incorporation by the Department of State in the State of Florida. The duration shall be perpetual until dissolved by the Board of Directors or by the State of Florida.

ARTICLE III

The purpose for which this corporation is organized is the transaction of any lawful business for which any corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE IV

The authorized capital stock of this corporation shall consist initially of 100,000 shares (one hundred thousand) of common stock, each having no par value. The Board of Directors shall be empowered to issue additional shares and/or classes of shares as they may deem appropriate and necessary.

ARTICLE V

The incorporator of this corporation is solely Harrell E. Corley whose address is: 2399 Sun Valley Circle, Winter Park, FL 32792

ARTICLE VI

The initial registered agent of the corporation shall be Kevin D. Rohe whose address is 470 West Central Farkway, Suite 1005, Altamonte Springs, FL 32714. Acceptance of this same designation is given by separate signature within this document.

ARTICLE VII

The initial board of Directors shall consist solely of Harrell F Corley whose address is as above.

ARTICLE VIII

The Board of Directors, as appointed from time to time, shall have the right to specify restrictions on the sale, transfer or other disposition of certificates of stock. Notice of any such restrictions shall be placed conspicuously as an endorsement on any and all such certificates of stock issued.

ARTICLE IX

Certificates of stock may be issued and paid for at such time as the Board of Directors may decide. All payments may be made in cash or real or personal property, leases, services, options to purchase, or any other thing or right of value. All certificates of stock so issued shall become fully paid as of the date of issue.

ARTICLE X

The judgement of the Board of Directors, honestly exercised, shall determine the value of any real or personal property, leases, services, options to purchase, or any other thing or right of value acquired in exchange for certificates of stock. This judgement of the Board of Directors shall be conclusive.

ARTICLE XI

The private property and personal assets of any and all directors, officers, employees, shareholders and all other individuals within the corporation shall be for ever exempt from any and all liability incurred by or on behalf of the corporation and for the debts and/or obligations of the corporation.

ARTICLE XII

This corporation shall indemnify its directors, officers, employees, shareholders and all other individuals within the corporation to the fullest extent permitted by the then prevailing laws of the State of Florida.

ARTICLE XIII

The Board of Directors of the corporation shall be vested with all power for operation and management thereof and shall create all senior management positions and appoint all officers to such positions. The Board shall determine delegation of these powers and any changes in said delegation, and shall so indicate in writing.

ARTICLE XIV

The Board of Directors shall have the power to adopt By Laws and to change same at any time, together with all other corporate procedures, specifications or documents. Such actions shall be indicated in writing.

ARTICLE XV

The Board of Directors shall have the power to enter into banking relationships or other business relationships which, at its discretion, it finds necessary for conduct of business.

ARTICLE XVI

All actions of the present or any future Board of Directors shall be subject to a vote of approval based on one vote per member of the Board and shall require acceptance by a majority of the members thereof.

ARTICLE XVII

Any controversy, dispute or deadlock regarding the actions of the present or any future Board of Directors in exercising its authority herein defined shall be resolved by the vote of the members thereof, under the provisions of Article XVI. Such determinations shall be binding on all members of the Board of Directors and on all other parties.
