ARTICLES OF INCORPORATION

OF

MOONFOX, INC.

I, the undersigned, hereby execute the following for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be MOONFOX, INC., and the principal place of business shall be Route 2, Box 2162, Melrose, Florida 32666, County of Alachua, State of Florida.

ARTICLE II - DURATION OF EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law. This corporation shall begin business on the day of filing of these Articles of Incorporation.
