The undersigned subscriber to these articles of Incorporation, being duly licensed to practice law under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Florida Statutes chapter 621, and other laws of the state of Florida.

ARTICLE I NAME

The name of this professional service corporation is DANIEL R. BRINLEY, P.A.

ARTICLE II PRINCIPAL OFFICE




