ARTICLES OF INCORPORATION OF INTERCODEV, INC.

The undersigned, acting as the incorporators of INTERCOLOR OF STATE under the Florida General Corporation Act, adopt the Idilor FLORIDA Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION: The name of the Corporation is INTERCODEV, INC.

ARTICLE II - COMMENCEMENT OF EXISTENCE: The existence of the corporation will commence on the date of filing these Articles of Incorporation.
