

ARTICLES OF INCORPORATION
OF

The undersigned hereby executes the following for the purpose of forming a corporation under the laws of the state of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE 1 - NAME

The name of the corporation shall be BEDROOM MASTERS, INC.

ARTICLE 2 - PROPOSE

The corporation is organized for the purpose of any and all lawful business under the laws of the State of Florida and the United States.

ARTICLE 3 - CAPITAL STOCK

The authorized capital stock of the corporation shall be common stock divided into one hundred (100) shares at One Hundred Dollar (\$100.00) par value. Such stock shall be issued by the Board of Directors for such consideration as in the opinion of the Board of Directors is equivalent to such market value thereof, and said stock may be paid for in money or tangible personal property, but not for labor, services, or stock, at a just valuation to be fixed by the Board of Directors or issued as partly paid when so ordered by the Board of Directors.

ARTICLE 4 - PREEMPTIVE

Every shareholder upon the sale for cash or any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE 5 - EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE 6 - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE 7 - INITIAL BOARD OF DIRECTORS

ARTICLE 9 - POWERS OF DIRECTORS

The Directors shall have all powers granted by the Laws of the State of Florida and the power to hold their meetings and to have one or more offices, and to keep the books of the corporation, except the original or duplicate stock ledger, outside the original county of its initial registered office, and the State of Florida, at such place or places as from time to time may be designated by the By-Laws or a Resolution of the board of Directors. Members of the Board of Directors may participate in regular meeting of the board of Directors by means of conference telephone provided by law.

ARTICLE 10 - INDEMNIFICATION

The corporation shall indemnify any officer, director, or any former officer or director, to the full extent permitted by law.

ARTICLE 11 - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is also subject to this reservation.
