ARTICLES OF INCORPORATION

OF

RUTE GROUP CORPORATION

ARTICLE I

CORPORATE NAME

The name of the corporation is RUTE GROUP CORPORATION.

ARTICLE II

NATURE OF CORPORATE BUSINESS

The Corporation may engage in or transact any or all activity or business permitted under the laws of the Unites States and of the State of Florida. The Corporation shall exist perpetually.
