ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CHARIOT EAGLE-WEST, INC. 7 NOV 24 AM 10: 18

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned FLORIDA corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Chariot Eagle-West, Inc.
- 2. The following Amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on November 19, 1997 in the manner prescribed by the Florida Business Corporation Act:

Section 1 of ARTICLE IV - Capital Stock (as amended) shall be deleted in its entirety and the following language shall be substituted therefor:
