ARTICLES OF INCORPORATION

TE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION, being a natural person competent to contract, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes for the practice of law, does hereby adopt the following Articles of Incorporation.

ī.


