ARTICLE IV

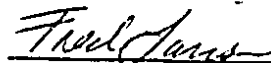

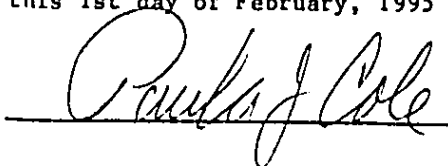
