ARTICLES OF INCORPORATION
OF

MAGIC CREDIT, INC.

The undersigned, for the purpose of forming a corporation under the Florida Corporation act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is:

MAGIC CREDIT, INC.

ARTICLE TWO

The duration of the corporation shall be perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized are:

1. To engage in the business of mortgage broker.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act and/or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried or in connection with or auxiliary to the foregoing business.
3. To do such other as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.




