ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of HENRY'S MARINE INCORPORATED under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is: HENRY'S MARINE INCORPORATED

The principal place of business of this corporation shall be:

ARTICLE II. COMMENCEMENT OF EXISTENCE
