



ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PAN AM WORLD SERVICES, INC.



Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is PAN AM WORLD SERVICES, INC. (the "Corporation"), Charter #P95000008931, filed on January 30, 1995.
- 2. The following Amendment to the Articles of Incorporation was adopted by all of the Directors of the Corporation on March 8, 1996 and by the sole Shareholder of the Corporation, the number of votes cast being sufficient for approval, on March 5, 1996 in the manner prescribed by Section 607.1003 of the Act:
