The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.
Name of Corporation

The name of this corporation shall be:

ISC OF CENTRAL FLORIDA, INC.

ARTICLE II Office Address

Nature of Business
