

ARTICLE I - NAME

The name of this corporation is: EMERGENCY MANAGEMENT, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation may engage in any activity of business, for profit or otherwise, permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 99 shares of single class common stock at no par value to no more than 10 people and issued and transferable only to natural non-resident alien persons.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which s/he already holds, shall have the right to purchase his/her pro rata share (rounded to the closest whole number and where there is a one half share, to be rounded up to the next whole number), at the price at which it is offered to others.
