The corporation may transact any and all lawful business for which corporation may be incorporated under the Laws of the STATE OF FLORIDA.

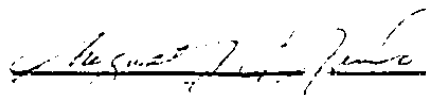
ARTICLE FOUR

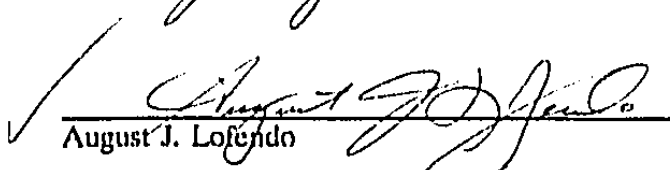
ARTICLE TEN
