## ARTICLES OF INCORPORATION

OF

## FAMILY DOCTORS, II, INC.

ARTICLE I. NAME. The name of the corporation shall be FAMILY DOCTORS, II, INC.

ARTICLE II. DURATION. The corporation shall exist perpetually.

ARTICLE III. PURPOSE. The purpose of this corporation is for providing medical services and for the transaction of any lawful business for which corporations may be incorporated under the law of the State of Florida.
