The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name: The name of the Corporation in: Sabat Consulting Services, Inc., principal address: 2304 Marsellos Ct., Valrice, Florida, 33594.

Article 2. Duration: The duration of the Corporation in perpetual.

Article 3. Purpose: The general purposes for which the Corporation is organized are the fellowing:
