ARTICLES OF INCORPORATION
OF
AMERICAN BARRICADE CORPORATION

The undersigned, for the purpose of forming a corporation under Chapter 607 Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME.

The name of the Corporation is: AMERICAN BARRICADE CORPORATION

ARTICLE 2. DURATION.

The duration of the Corporation is perpetual.

ARTICLE 3. PURPOSE.

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE 4. CAPITAL STOCK.

The aggregate number of shares which the Corporation is authorized to issue is one thousand (1,000) shares of common stock.

ARTICLE 5. PRINCIPAL OFFICE.

The principal office of the Corporation is 6322 Crews Lake Road, Lakeland, Florida 33813.

ARTICLE 6. INITIAL REGISTERED OFFICE AND AGENT.

The street address of the initial Registered Office of the Corporation is 5025 South Dossey Road, Lakeland, Florida 33811, and the name of its initial Registered Agent at that address is Mike Balestra.

ARTICLE 7. INCORPORATOR.

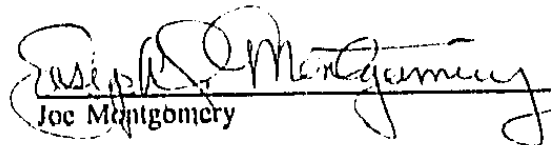
ARTICLE 8. AMENDMENT

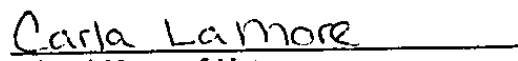
