I, the undersigned subscriber to these Articles of Incorporation, being a natural person of legal age and fully competent to contract, hereby affirm my intention and desire to form a Professional Service Corporation under the laws of the State of Florida pursuant to the provisions of Chapter 621 of the Florida Statutes. The irofessional Service Corporation Act.

ARTICLE I

The name of this corporation shall be:

ARTICLE II

NATURE OF CORPORATE BUSINESS

The general nature of the business to be transacted by the corporation shall be and is to engage in every aspect of the general practice of medicing.
