ARTICLES OF INCORPORATION FOR

ME, the undersigned hereby associated ourselves together for the purpose of becoming a corporation under and by virtue of the laws. of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

CORPORATE NAME

The name of this corporation shall be : Advantage Massage Associates, Inc.

ARTICLE_II NATURE OF BUSINESS AND POWERS

The objects and purposes of this corporation and the general nature of the business or businesses to be transacted shall be as follows:
