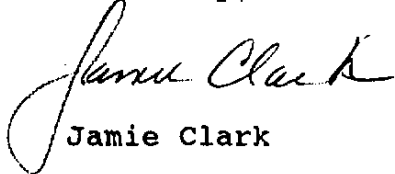
Dear Sir or Madame;
