The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

Article I

The name of the corporation shall be BonaVenture Properties, Inc.

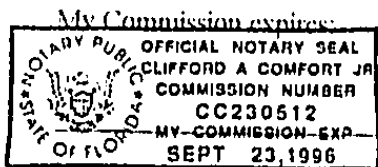
