ARTICLES OF INCORPORATION OF ALLIED SIGN MASTERS. INC.

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be ALLIED SIGN MASTERS, INC.

ARTICLE_II

CORPORATE DOMICILE

The principal corporate domicile shall be 3800 N.W. 9th Street, Delray Beach, Florida 33445.

ARTICLE III

NATURE OF BUSINESS

The Corporation is organized for the purposes of engaging in any activity or business permitted under the laws of the United States or of this State, more specifically set out as follows:

- 1. To do all such activities and engage in all such transactions as are necessary to operate a service business.
- 2. To transact any lawful business for which Corporations may be incorporated under the Florida General Corporations Act or angage in any other trade of business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with the foregoing business.
