

Articles of Incorporation

1. NAME. The name of the corporation is: International Export, Inc.
2. PLACE OF BUSINESS. The principal place of business and mailing address of the corporation is: 131 Zamora Avenue, Suite #1, Coral Gables, Florida 33134.
3. TERM. The duration of the corporation shall be perpetual.
4. PURPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes.
5. CAPITAL STOCK. The corporation shall have the authority to issue 20 (twenty) shares of common stock, in one class only, each with a par value of \$0.01.
