We, the undersigned, hereby associate ourselves together for the purpose of incorporation under the laws of the State of Florida, providing for the formation, habilitation, rights, privileges and immunities of a corporation for profit and to that end we set forth:

ARTICLE I

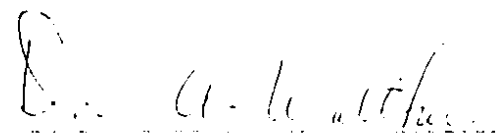

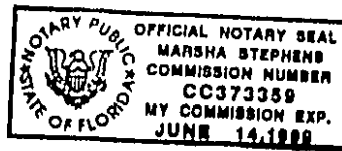
