The undersigned subscriber to these articles of incorporation, adopt these articles to form a corporation in accordance with the laws of the State of Florida.

ARTICLES I. NAME

The name of the corporations is:

"MRI Funding, Inc."

ARTICLE II. FISCAL YEAR

The fiscal year of the corporation shall be the calendar year ending December 31.

ARTICLE III. PURPOSE

The corporation is formed to engage in every phase and aspect of business practice. In addition, the corporation may invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, including applications for reimbursement from the Florida Department of Environmental Protection under various petroleum cleanup reimbursement programs. The corporation may also own real or personal property necessary for its business operations.

ARTICLE IV. TERM OF EXISTENCE

The corporation shall have perpetual existence commencing on the date these articles are filed with the Department of State of Florida.

ARTICLE VI. CAPITAL STOCK

The capital stock of the corporation shall be one thousand (1,000) shares of common stock having a par value of one cent (\$.01) per share.

ARTICLE VII. REGISTERED OFFICE AND AGENT

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.


