ARTICLE I - Name

The name of this corporation is COL ZORA, CORP.

ARTICLE II - Duration

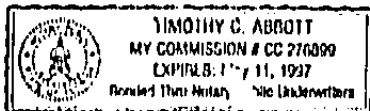
