Article One

The name of the Corporation is Refrigerant Recovery Inc.

Article Two

The period of its duration is perpetual.

Article Three

The purpose for which this corporation is organized is to establish, create, and maintain a corporation, wherein, we will develop and operate a business which will subscribe to the federal standards in the removal of hazardous waste material "specifically" removal of "oils" from refrigeration equipment.


