THIS IS TO CERTIFY that I, the undersigned, for the purpose of forming a corporation under the provisions of Florida Statutes 1991, Chapter 607, and statutes amondatory thereof and supplementary thoroto, do hereby make, subscribe, acknowledge and file these Articles of Incorporation, and I do certify that:

1. The name of the corporation is:

SPECIAL CARE SERVICES, INC.

2. The major purpose of the corporation will be to engage in the business of a home health agency. In addition, the general nature of the business transacted shall be:

To engage in any one or more of the businesses and to exercise any or all the powers authorized and permitted by the said Statutes to corporations formed thereunder.

Further, and not by way of limitation of the preceding paragraph, to enter into and perform contracts of every kind and nature; to act as agent and representative of other persons and corporations; to own, buy, sell, mortgage or lease real and personal property of every kind and nature and wheresoever situate.

3. The amount of capital stock authorized shall be five hundred (500) shares of Common Stock at a par value of TEN (\$10.00) DOLLARS per share.

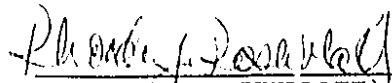

11. The private property of the stockholders, officers and directors shall not be subject to the payment of the obligations of the corporation to any extent.

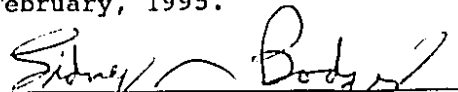

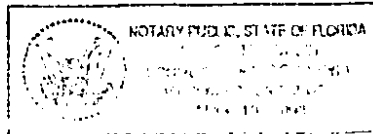

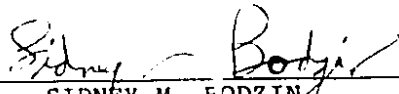
