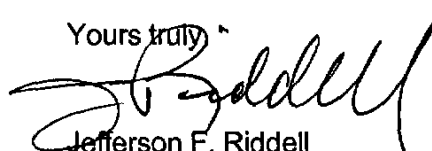
Therefore, pursuant to our recent telephone discussion had with your office we enclose the following:
