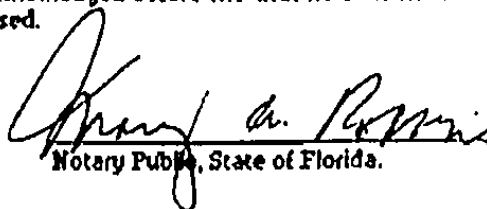
ARTICLE XI AMENDMENT

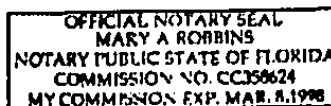
