

ARTICLES OF INCORPORATION



OF

TKW Enterprises, Inc.

THE UNDERSIGNED SUBSCRIBER, acting as Incorporator of a corporation (hereinafter referred to as the 'CORPORATION'), under the provisions of the Statutes of the State of Florida, does hereby make, subscribe, acknowledge and file the following Articles of Incorporation.

ARTICLE 1:

1.1) Name: The name of the Corporation is:

TKW Enterprises, Inc.

ARTICLE 2:

2.1) <u>Purposes</u>: The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 3:

- 3.1) Number of Authorized Shares: The aggregate number of capital stock which the Corporation shall have authority to issue is One Thousand (1,000) of Common Stock of a par value of One Dollar (\$1.00) per share.
- 3.2) Payment for Shares: The consideration for the issuance of shares of capital stock of the Corporation may be paid, in whole or in part, in money, or in other property, tangible, intangible or in labor or services actually performed for the Corporation. When payment of the consideration for which such shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid

and non-assessable. In the absence of fraud in the transaction, the judgment of the Board of Directors or the Stockholders, as the case may be, as to the value of the consideration received for such shares shall be conclusive.
