ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE  
NAME

The name of the corporation is: DARKHORSE STUDIOS INC.

DURATION

This corporation shall commence existence as of February 10, 1995.
