## ARTICLES OF INCORPORATION

OF

## MARY KEW, INC.



The undersigned, being qualified to act as an Incorporator under the Florida General Corporation Act, adopts the following Articles of Incorporation for the purpose of organizing a Corporation under the Act:

1. The name of the Corporation is:

MARY KEW, INC.

- 2. The duration of the Corporation is perpetual.
- 3. The street address of the registered office of the Corporation in the State of Florida shall be 12546 Highway 301 South, Dade City, Florida 33525, and the name of the Registered Agent at such address is MARY KEW.
