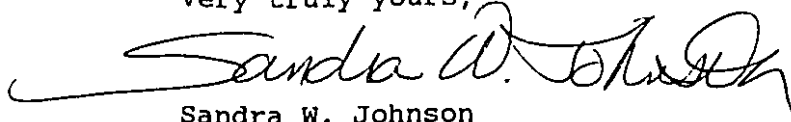

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I
Name

The name of this corporation shall be REL TRUCKING, INC.

Article II
Principal Office and Mailing Address

The principal place of business and mailing address of this corporation shall be 5946 Lakeridge Avenue, Jacksonville, Florida 32211.

Article III
Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 100,000 shares of common stock having a par value of \$1.00 per share.

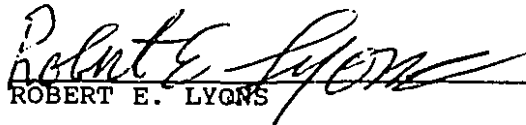
