ARTICLES OF INCORPORATION

OF

COASTAL REPORTING, INC.



ARTICLE I

NAME

The name of the corporation shall be COASTAL REPORTING, INC.

ARTICLE II

FFFECTIVE DATE

GENERAL NATURE OF BUSINESS 1-31-95 ...

This corporation is authorized to carry on and license and authorize others to carry on all or any part of the several businesses enumerated in this Article, including all of the following:

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida, and further, without limitation, may conduct all | es of business related to construction, repair, renovation maintenance of buildings and other improvements to real estate, and any and all matters relating in any way to such activities. corporation may also develop, subdivide, and resell real property for profit, and may purchase, sell and otherwise deal in and with, in any manner whatsoever, all types of property, real, personal, fixtures, equipment and all varieties of inventory, supplies and other types of commerce.
