ARTICLE ONE

The name of the corporation is **N & K AUTO WHOLESALERS, INC.**, principal address of the corporation is: 2483 Oak Garden Lane, Hollywood, Florida 33020. TALLAHASSEE, FLORIDA

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
