CERTIFICATE OF INCORPORATION

OF

I, the undersigned, make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation for profit under the laws of the State of Florida, for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation is:

AWARENESS PRODUCTS, INC.

ARTICLE II

The general nature of the business to be transacted, conducted and engaged in shall be as follows:

- A. Sale of health products
- B. To own, acquire, buy, sell, deal in and lease, hold or improve real estate and fixtures and personal property, and with that end in view to acquire by purchase, lease, hire or otherwise, land, tenements, hereditaments, or any interest therein, and to subdivide and improve the same; to act as a contractor, builder and developer and generally to hold, manage, deal with and improve the property of the company; to carry on a general real estate development and construction business and to conduct a brokerage agency and commission business for others in the purchase, sale and management of real estate and negotiations for loans thereon; to act as agent for insurance companies in soliciting and receiving applications for fire, casualty, plate glass, elevator, accident, health, rent, burglary, boiler, marine and life
