

ARTICLES OF INCORPORATION OF

KENNY FAMILY ENTERPRISES, INC.

ARTICLE I- NAME

The name of the corporation is KENNY FAMILY ENTERPRISES, INC.

ARTICLE II- PRINCIPAL OFFICE

The address of the principal office and the mailing address of the corporation is 17125 SW 54TH STREET, FT. LAUDERDALE, FL. 33331

ARTICLE III- SHARES

The corporation shall be authorized to have 1,000 shares of common stock each having a par value of \$1.00, and each of which shall be entitled to one vote, as issued.
