The undersigned subscriber to these Articles of LANGCON STATE Incorporation, a natural person competent to contract, hereby The forms a corporation under the laws of the State of FLORIDA.

#### ARTICLE I NAME

The name of the corporation shall be C-P TRANSPORTATION, INC.

#### ARTICLE II NATURE OF BUSINESS
