The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be "ASH TECHNOLOGIES INC.", and it shall hereinafter be referred to as "Corporation".

ARTICLE II

The principal place of business of this Corporation shall be: 1223 Golfview Drive, Daytona Beach, Florida 32114. The mailing address of this Corporation shall be: 1223 Golfview Drive, Daytona Beach, Florida 32114.

ARTICLE III

The time and date on which corporate existence of this corporation shall begin is February 6, 1995, and this corporation shall have a continuance perpetual existence thereafter.

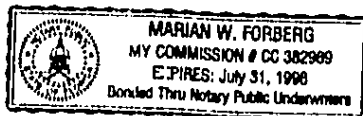
