#### ARTICLES OF INCORPORATION FOR MARTIN PAINTING, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE I: NAME

### ARTICLE XI:


