DEAR SIRs:

WE ARE SUBMITTING THIS LETTER FOR PURPOSES OF EXPLANATION AS TO WHY OUR COMPANY DID NOT FILE FOR THIS YEAR OF 2000.

HAVING SPOKEN TO MS.MICHELLE MILLIGAN TODAY , WHO IS A REPRESENTATIVE OF YOUR OFFICE, I EXPLAINED THAT AS HAD PREVIOUSLY HAPPENED ONCE BEFORE DUE TO THE FACT THAT WE HAD MOVED OUR OFFICE LOCATION, AND ALTHOUGH HAD SENT CHANGE OF ADDRESS CARDS TO THE U.S. POST OFFICE INFORMING THEM OF OUR NEW ADDRESS, OUR MAIL HAD BECOME BACKLOGGED, NOT FORWARDED TO OUR NEW OFFICE LOCATION IN A TIMELY MANNER, AND IN MANY INSTANCES SUCH AS THIS ONE WITH RESPECT TO YOUR OFFICE, AS A RESULT, WE DID NOT RECEIVE ANY WRITTEN COMMUNICATION INFORMING US OF A FILING FEE, FILING DEADLINE, AND THUSLY WERE NOT AWARE THAT WE WERE IN ARREARS OF PAYMENT AND/OR FILING FEES. HAVING EXPLAINED THIS TO MS. MILLIGAN, I ALSO INFORMED HER THAT THIS PAST YEAR IN NOVEMBER, 1999, WE AGAIN MOVED OUR OFFICES TO OUR CURRENT ADDRESS, AND DID IN FACT NOTIFY THE U.S. POST OFFICE AGAIN OF OUR CHANGE OF ADDRESS BEFORE MOVING TO OUR CURRENT ADDRESS. UPON RECEIVING THIS NOTICE OF ADMINISTRATIVE DISOLUTION OR REVOCATION IN THE MAIL YESTERDAY EVENING, THE NOTICE WAS SENT TO OUR OLD ADDRESS AND APPARANTLY RETURNED TO THE POST OFFICE WITH AN AFFIXED YELLOW STICKER WITH A NOTIFICATION WITH OUR NEW ADDRESS ON IT STATING "NOTIFY SENDER OF NEW ADDRESS". WITH ALL DUE RESPECT, I CAN ONLY SAY THAT I AM SURE THAT YOUR OFFICE DID IT'S DUE DILLIGENCE IN SENDING NOTIFICATION TO OUR COMPANY WITH RESPECT TO ALL MATTERS, HOWEVER WE FEEL THAT THE PROBLEM THAT CAUSED THIS SITUATION FOR THE MOST PART RESTS WITH THE PROBLEM OF OUR RECEIVING OUR MAIL THROUGH THE POSTAL SERVICE. MAY I FURTHER ADD THAT THE SAME SITUATION HAS ARISEN WITH RESPECT TO OUR MAIL ARRIVING AT THIS ADDRESS
